CALL TO ORDER - The Governing Body met for a regular meeting and the following commission members were present in the commission chambers: Mayor Griff Martin, Mayor Pro-Tem Holly Pittman, Commissioners Nancy Bauder, Edd Hingula and Jermaine Wilson.

Staff members present: Interim City Manager Patrick Kitchens, Assistant City Manager Penny Holler, Convention & Visitors Bureau Manager Kristi Lee, Deputy Parks & Recreation Director Brian Bailey, Parks & Recreation Director Steve Grant, Deputy Police Chief Major Dan Nicodemus, Public Information Officer Melissa Bower, Public Works Director Brian Faust, City Attorney David E. Waters and City Clerk Sarah Bodensteiner.

Mayor Martin asked everyone to stand for the pledge of allegiance followed by silent meditation.

PROCLAMATIONS:

Economic Development Week – Mayor Martin read the proclamation declaring May 6-10, 2024 as Economic Development Week. The proclamation was accepted by Mary Mack with Leavenworth County Development Corporation.

National Police Week – Mayor Martin read the proclamation declaring May 12-18, 2024 as National Police Week. The proclamation was accepted by Deputy Police Chief Major Dan Nicodemus.

Leavenworth Public Works Week – Mayor Martin read the proclamation declaring May 19-25, 2024 as Leavenworth Public Works Week. The proclamation was accepted by Public Works Director Brian Faust.

National Travel & Tourism Week – Mayor Martin read the proclamation proclaiming May 19-25, 2024 as National Travel & Tourism Week. The proclamation was accepted by Convention & Visitors Bureau Manager Kristi Lee.

150th **Anniversary of the United States Disciplinary Barracks** – Mayor Martin read the proclamation declaring May 21, 2024 as the celebration of the Sesquicentennial Anniversary of the United States Disciplinary Barracks. Consideration of Previous Meeting Minutes:

Commissioner Wilson moved to accept the minutes from the April 23, 2024 regular meeting. Commissioner Hingula seconded the motion and the motion was unanimously approved. Mayor Martin declared the motion carried 5-0.

Second Consideration Ordinance:

Second Consideration Ordinance No. 8243 Rezoning 707 Pawnee Street from Office Business District to High Density Single Family Residential – Interim City Manager Patrick Kitchens reviewed the Ordinance. There have been no changes since first introduced at the April 23, 2024 meeting.

Mayor Martin called the roll and the Ordinance No. 8243 was unanimously approved.

Second Consideration Ordinance No. 8244 Special Use Permit for College or University Use at 4100 S 4th Street – Interim City Manager Patrick Kitchens reviewed the Ordinance. There have been no changes since first introduced at the April 23, 2024 meeting.

Mayor Martin called the roll and the Ordinance No. 8244 was unanimously approved.

Mayor's Appointments:

Mayor Martin moved to reappoint to the Board of Zoning Appeals Kathy Kem to a term ending May 1, 2027, appoint to the Building Code Board of Appeals Brent Motley to a term ending May 1, 2029, reappoint to the Electrical Board of Appeals Craig Schmidling to a term ending May 1, 2029, reappoint to the Leavenworth Planning Commission Kathy Kem, Don Homan, and Bill Waugh to terms ending May 1, 2027, reappoint to the Leavenworth Preservation Commission Richard Jackson to a term ending April 15, 2027, reappoint to the Mechanical Board of Appeals Carl Kreutzer to a term ending May 1, 2029, reappoint to the Plumbing Board of Appeals Michael McCann to a term ending May 1, 2029. Commissioner Bauder seconded the motion and the motion was unanimously approved. Mayor Martin declared the motion carried 5-0.

2024 Edward Byrne Memorial Justice Assistance Grant Application – Deputy Police Chief Major Dan Nicodemus requested authority to apply for the 2024 Edward Byrne Grant in the amount of \$350,000. On April 23, 2024 notification was made to the Police Department that they were eligible to apply. The selection was based upon previous discussions with Congressional leadership regarding law enforcement needs. One area identified and selected for this program is the replacement of aging and problematic bomb unit equipment. The funds would be used in the following areas:

- Bomb Suit Replacement
- Bomb Robot Replacement current robot is 21 years old and manufacturer no longer supplies replacement parts or support
- Replacement of other outdated bomb equipment

Commissioner Hingula moved to approve the 2024 Edward Byrne Memorial Justice Assistance Grant Application in the amount of \$350,000. Commissioner Wilson seconded the motion and the motion was unanimously approved. Mayor Martin declared the motion carried 5-0.

Resolutions:

Resolution B-2370 Resolution of Support for Grant Application for Downtown ADA Sidewalk Ramp Improvements Project – Public Works Director Brian Faust presented for consideration a Resolution of Support for the Transportation Alternatives (TA) Grant Application for the Downtown ADA Sidewalk Ramp Improvements Project. In 2023, the City hired Wilson & Co., to design ADA compliant ramps in the downtown. During the design process, the City was notified that KDOT was accepting 'concept papers' for possible 2024 TA projects. The City submitted a concept paper and were notified that the concept is eligible for federal funds for the TA Program. The TA Program is an 80/20 matching program that helps pay for construction and construction engineering. Right of Way acquisition and utility relocation are not covered by the grant. The total estimated construction and construction engineering project cost is \$590,000. An additional \$1,200 is estimated for utility relocation. If the 80% grant is awarded, the cost to the City is \$119,200. If we receive the additional 20% match from Highway Safety Improvement Program, the City's cost would only be for the utility relocation. Funding is available in the Grant Matching Capital Projects Fund.

Mayor Martin:

· Asked when will we hear if we're awarded

Mr. Faust:

Should hear fairly quickly, but no specific date

Commissioner Bauder moved to approve Resolution B-2370 Resolution of Support for the Downtown ADA Sidewalk Ramp Improvements Project, as presented. Commissioner Pittman seconded the motion and the motion was unanimously approved. Mayor Martin declared the motion carried 5-0.

Bids, Contracts and Agreements:

Consider Award of Design Services Contract for 10th and Limit Safety Improvements Project — Public Works Director Brian Faust presented for consideration approval of the design services contract for the 10th and Limit Safety Improvements Project funded in Federal Fiscal Years 2025 and 2026. In December of 2021, the City was notified of a grant opportunity for intersection improvements that would improve the safety at high-crash locations. The Police Department identified the intersection of 10th and Limit as one of the City's high crash locations. The City worked with Midwest Engineering to evaluate options for safety improvements at this location. Based on submittal, the City received a letter from KDOT stating we are eligible for up to \$1,000,000 in funding to help cover the costs of these improvements. The grant is a 90/10 that covers the construction and the construction engineering. The City will need to pay 10% of the construction/construction engineering costs and 100% for the design, right-of-way acquisition (if needed), utility relocations (if needed) as well as any construction costs that exceed \$1M. The traffic signals were identified as reaching their anticipated life and the report recommended that the signals be replaced in 2025 or 2026. The grant will cover 90% of the cost. Six (6) firms were sent the request. Two (2) proposals were received. The engineering design work is a non-participating cost for the Federal-Safety Program,

making the City responsible for the entire cost of the design with a design fee not to exceed \$150,343.62. Funding is available in the Grant Matching Capital Projects Fund.

Commissioner Pittman:

· Asked what the improvements would be

Mr. Faust:

• Reviewed the improvements

Commissioner Hingula:

· Asked if there is any type of schedule

Mr. Faust:

It is a 14 month process, looking at 2026 for construction

Commissioner Bauder moved to approve the Design Services Contract for the 10th and Limit Safety Improvements Project with Merge Midwest Engineering, in an amount not to exceed \$150,343.62. Commissioner Wilson seconded the motion and the motion was unanimously approved. Mayor Martin declared the motion carried 5-0.

Staff Report:

Central Business District Special Event Street Closure Policy — Interim City Manager, Patrick Kitchens presented for consideration a new policy that governs events in the Central Business District that require street closures. Over the past several years the City has received a number of Special Event applications for events held in the Central Business District that are accompanied by street closure requests. In the past City Commissions have not been inclined to allow the closures particularly on Saturdays. Given the increase in requests for more events associated with street closures, staff created a policy proposal to add a Central Business District Street Closure that is an expansion of existing policies associated with Haymarket Square, RFCC and Park Shelters. There is currently no fee for Street Closures within the Central Business District. The proposal of any person or group interested in having an event in the Central Business District shall complete an application and pay a fee of \$25. Additionally, there will be a fee of \$100 per city block for street closure. Finally, any costs associated with towing of vehicles from the event area will be reimbursed by the applicant to the City of Leavenworth. The fee for street closure is based upon City staff time associated with notification and closing of streets. Other logistics, including but not limited to trash, electrical, portable restrooms, picnic tables, or security associated with the event is the sole responsibility of the event coordinator. Parades would not be included in Central Business District Street Closure policy.

Commissioner Bauder:

- Does not recall that the City has ever charged for closing streets and in some cases the entire downtown was closed in the past
- In generating sales tax, we are offsetting those costs from the sales tax generation

Mayor Martin:

- Stated the costs are real
- Asked if transient guest tax dollars can be used

Wants to bring in events

City Attorney David Waters:

 The City's direction is broad regarding transient guest tax, and transient guest tax dollars are typically used for Convention and Visitor's Bureau

Commissioner Pittman:

There are still a lot of questions then just money, is there a limit, there is more to this policy then
just cost, guidelines and procedures are needed

Commissioner Bauder:

 We'd need to look at transient guest tax and the numbers; that could then determine the number of events

Commissioner Wilson:

Open to exploring/looking into transient guest tax to support

Mr. Kitchens:

- Recapped the comments/feedback from the Commissioners: find money, first looking at transient guest tax
- Need specifics on numbers; we will have during the budget process
- Fees don't appear to be entirely off the table

Mayor Martin:

Would like more accurate numbers, provided number of \$100 is very conservative

Mr. Kitchens:

 Suggested the City Commission move forward with First City Creative's applications for events on August 3, 2024 and December 7, 2024 while staff take the feedback from the Commission and come back with more information for the policy development

City Clerk Sarah Bodensteiner:

Provided details of the events and road closure requests

There was Consensus from the City Commission to approve the special event road closures for the First City Creative's events on August 3, 2024 and December 7, 2024.

ITEM:

This evening, WSP will update the City Commission on the status of the development of our SS4A Vision Zero Action Plan.

BACKGROUND:

The City of Leavenworth applied for and was awarded a \$350,000 planning grant to develop a SS4A Vision Zero (Comprehensive Safety) Action Plan. The purpose of program is to improve roadway safety by significantly reducing or eliminating roadway fatalities and serious injuries for all users of our highways and roadways in Leavenworth. Recommendations contained within the plan may relate to street design, funding allocations, education, and emergency responders. The action plan will also be used to identify and prioritize a set of Vision Zero street projects and potential system-wide safety programs.

The action plan will provide the documentation necessary to meet the requirements for the City of Leavenworth to apply for future Safe Streets and Roads for All Discretionary Grant Opportunities.

ISSUE:

The National Society Daughters of the American Revolution (DAR) Captain Jesse Leavenworth Chapter would like to present the City of Leavenworth an American 250 Patriots Marker to be hung in the light court of City Hall.

STAFF RECOMMENDATION:

Staff recommends approval.

BACKGROUND:

Staff met with representatives of the Captain Jesse Leavenworth Chapter of DAR and evaluated their request to provide the City of Leavenworth the gift of an America 250 Patriots Marker. If approved it will be hung in the City Hall Light Court. It is similar in design to the World War II and Korean and Vietnam markers currently located there.

The marker reads:


"Revolutionary War Patriots. This marker commemorates the men and women who achieved America Independence. These Patriots, believing in the noble cause of liberty, fought valiantly to found a new nation. 1775-1783"

BUDGET IMPACT:

There is no significant budget impact. The marker will be a gift to the City of Leavenworth and city staff will install it.


Current focus:

- The DAR is promoting the 250th revolutionary period (Boston Tea Party in 2023 to the signing of the Treaty of Paris in 2033).
- As part of our Historic Preservation mission, the DAR is placing America 250 Patriots Markers across the country.
 - o The marker text is the same on all markers, regardless of size or location.
 - To date, 207 marker applications have been received by DAR, including two in Kansas.
 - Forty-eight states and the District of Columbia have at least one marker.
 - Markers in France, Italy and Spain are planned for fall of 2024.

Objective: Place an America 250 Patriots Marker in Leavenworth, Kansas

- Captain Jesse Leavenworth Chapter would like to gift an America 250 Patriots Marker to the citizens of Leavenworth.
- Permission to place the marker must be secured in writing by the property owner.
- Markers come in three sizes: 30" x 30", 24" x 24", or 20" x 20" and are cast in bronze.
- Markers (depending on the size) may be pole mounted or stone mounted.
- The chapter would host a dedication ceremony.
- The text of the marker reads: Revolutionary War Patriots. This marker commemorates the men and women who achieved American independence. These Patriots, believing in the noble cause of liberty, fought valiantly to found a new nation. 1775-1783.

Policy Report No. 5-2024 Municipal Service Center Storage Building May 28, 2024

ISSUE:

The Police Department and Public Works Department are requesting authority to purchase a storage building to be placed at the Municipal Service Center. The building will house expensive vehicles and equipment from both departments.

STAFF RECOMMENDATION:

Staff recommends purchase of a storage building from Quality Structures Incorporated (QSI) in the amount of \$71,730.

BACKGROUND

In 2022, the Police Department and Public Works Department requested \$150,000 in the 2023 Capital Improvement Program (CIP) budget for a storage building at the Municipal Service Center. The building will store expensive vehicles and sensitive equipment belonging to the Police Department and Public Works. Specifically, the Police Department plans to house the SWAT truck and Bearcat armored vehicle there. Public Works intends to house various equipment that should be stored indoors including their asphalt hot box, crack seal machine, skid steer and asphalt roller.

The project was approved by the City Commission and scheduled in the 2023 CIP. Initial quotes for the building exceeded funding for the project in 2023 and additional funds totaling \$300,000 were allocated in the 2024 CIP budget. Staff has since revisited the type of building and resolicited quotes from additional vendors. Of the three returned quotes, QSI was the lowest in the amount of \$71,730. Staff has also assumed the project manager role and will oversee contracting of the remaining work necessary to complete the building project to include a concrete slab, electrical, and plumbing work. It is anticipated that we will still be within the original appropriation of \$150,000.

BUDGET IMPACT

The City of Leavenworth allocated \$300,000 in the 2024 CIP budget for this building project. The remaining funds will be required to finish concrete, plumbing and electrical work once the building is constructed. Approval for those services, if necessary, will be brought back to the City Commission at a later date.

COMMISSION ACTION

Authorize the Police Department to purchase a storage building from QSI for \$71,730.



ISSUE:

Consider approval of the contract with Alfred Benesch & Company for the development of the 2025 Pavement Management Plan (PMP) and to finalize the Level of Service (LOS) Prioritization Model.

BACKGROUND:

A Pavement Management Plan is an asset management process used to allocate resources effectively and to maximize the service life of pavements. This process includes the systematic process for inspection, evaluation, project planning and maintenance of the entire street pavement network. The information collected as part of this process is used to identify appropriate maintenance strategies for each street based on pavement condition, expected service life, desired level of service and street classification.

Pavement Management Strategies:

- Preventative Maintenance: application of crack seals, thin non-structural surface seals (granite seal/pressure pave/micro-surfacing) and other treatments used to maintain and extend the service life of the pavement. Surface seals are most effective on streets that are in relatively good condition – keeping the good roads good.
- Major Rehabilitation: application of structural pavement overlays and other treatments to significantly improve the service life of the pavement. Mill and overlay streets may need localized full-depth base repairs and removal/replacement of the top 1 ½" to 2" of asphalt.
- Reconstruction: replacement of existing pavement with new pavement and base materials on streets to restore the original service life of the pavement.
- Stop-Gap Measures: includes pothole patching and small-scale full depth patching projects to address localized severe pavement failures.

Advantages of the PMP include:

- Improving the quality of the City's street network in a financially responsible manner.
- Data-Driven Defendable Project Prioritization Process that helps:
 - Maximize value and return on investment.
 - Prioritize projects not only on PCI (Pavement Condition Index), but considers other impacts to residents and motorists such as roadway classification, deterioration type, peripheral assets, traffic volumes, and many other factors.
- Implementing a plan that considers both immediate and long-term needs.
- Improved identification and submittals of funding sources/opportunities to supplement local City resources.
- Track and improve design and construction processes associated with roadway maintenance and reconstruction.

Starting in 2016, staff contracted with 'Stantec' to provide an independent objective pavement condition analysis of the City streets using digital evaluation techniques. The result of that effort was a pavement program between 2016 and 2019 that included a large number of streets that received 'Preventative Maintenance' using a surface granite seal.

In 2019, 'Stantec' re-evaluated and updated the pavement condition of City streets. At that time, the City's stated goal was to improve street conditions with an emphasis on bringing the City's overall street PCI rating up to a range of 65 – 75 (fair to satisfactory). The overall street condition, based solely on the PCI ratings, decreased from 54.2 in 2016 to 51.0 in 2019. An initial decrease in the PCI is not unexpected as it can take time to reverse the downward momentum of pavement deterioration. The city also used a combination of 'Preventative Maintenance' and 'Major Rehabilitation' in our program.

In 2023, the city again utilized Stantec to evaluate the roadways to help determine what effect previous pavement treatments where having. The PCI is starting to turn around and it showed an overall increased from 51 to 54.

In 2024, the city funded streets where 'Major Rehabilitation' was needed and did not apply any surface seal. A number of our streets are at a point were surface treatment is no longer effective and a failure to quickly address with a mill/overlay will result in the need for full reconstruction.

For 2025, the Pavement Management Plan and Prioritization Model includes:

- (1) Developing a specific street project list for 2025 with the majority of work involving mill/overlay (major rehabilitation) and the remainder either a Granite Seal or Ultrathin Bonded Asphalt Surfacing (UBS) treatment. The micro-surfacing done in the past has not held up and will not be used again until staff is convinced that issues have been addressed.
- (2) Finalizing the Level of Service (LOS) Prioritization Model with implementation plan. This model will be used to identify projects starting this year (2025).

Alfred Benesch has worked with Leavenworth since 2022 and has extensive successful experience in helping communities develop Comprehensive Pavement Management Programs. They also understand funding limitations and challenges working in communities of all sizes.

BUDGET IMPACT:

The cost for the 2025 plan development will occur in 2024. The current budget amount for 2024 is \$2,000,000.

ARTICLE 1 - EFFECTIVE DATE

The effective date of this Agreement shall be

ARTICLE 2 - GOVERNING LAW

This Agreement shall be governed by the laws of the State of Kansas and the codes of the City of Leavenworth

ARTICLE 3 - SERVICES TO BE PERFORMED BY ENGINEER

Engineer shall perform the Services described in Attachment A, Scope of Services, in accordance with applicable sections of the City of Leavenworth Design Criteria and Drafting Standards of latest revision.

Owner shall pay Engineer in accordance with the Attachment B, Compensation.

ARTICLE 5 - OWNER'S RESPONSIBILITIES

ARTICLE 8 - STANDARD OF CARE

Engineer shall exercise the same degree of care, skill, and diligence in the performance of Services as is ordinarily possessed and exercised by a professional engineer under similar circumstances.

ARTICLE 9 - INDEMNIFICATION AND INSURANCE

Engineer hereby agrees to fully indemnify and hold harmless Owner and any of its departments, divisions, agencies, officers, employees and elected officials from all loss, damage, cost, or expenses specifically including reasonable attorneys' fees and other expenses of litigation incurred by or on behalf of the Owner and any of its officers, employees or elected officials to the extent caused by Engineer's negligent performance of Services under this Agreement. Engineer specifically agrees that this duty to indemnify and hold harmless will apply to the following:

- Claims, suits, or action of every kind and description to the extent caused by the negligent acts, errors, or omissions of the Engineer, its employees, agents, or subcontractors.
- b. Injury or damages received or sustained by any party to the extent caused by the negligent acts, errors, or omissions of the Engineer, its employees, agents, or subcontractors.

Engineer shall purchase and maintain during the life of this Agreement, insurance coverage which will satisfactorily insure him against claims and liabilities which arise because of the execution of this Agreement.

The insurance coverages are as follows:

- (1) Commercial General Liability Insurance, with a limit of \$1,000,000 for each occurrence and \$2,000,000 in the general aggregate.
- (2) Automobile Liability Insurance, with a limit of \$1,000,000 for each accident, combined single limit for bodily injury and property damage.
- (3) Worker's Compensation Insurance and Employer's Liability Insurance, in accordance with statutory requirements, with a limit of \$500,000 for each accident.
- (4) Professional Liability Insurance, with a limit of \$1,000,000 for each claim and aggregate.

Prior to issuance of the Notice to Proceed by Owner, Engineer shall have on file with Owner certificates of insurance acceptable to Owner. Said certificates of insurance shall be filed with Owner within ten (10) days of renewal or may be submitted with each agreement.

Engineer shall also maintain valuable papers insurance to assure the restoration of any plans, drawings, field notes or other similar data relating to the work covered by this agreement, in the event of their loss or destruction, until such time as the work has been delivered to the Owner.

Upon completion of all Services, obligations, and duties provided for in this Agreement, or if this Agreement is terminated for any reason, the terms and conditions of this Article shall survive.

ARTICLE 10 - LIMITATIONS OF RESPONSIBILITY

Engineer shall not be responsible for: (1) construction means, methods, techniques, sequences, procedures, or safety precautions and programs in connection with the Project, (2) the failure of any contractor, subcontractor, vendor, or other Project participant, not under contract to Engineer, to fulfill contractual responsibilities to the Owner or to comply with federal, state or local laws, regulations, and codes; or (3) procuring permits, certificates, and licenses required for any construction unless such responsibilities are specifically assigned to Engineer in Attachment A, Scope of Services.

ARTICLE 11 - OPINIONS OF COST AND SCHEDULE

Since Engineer has no control over the cost of labor, materials, or equipment furnished by others, or over the resources provided by others to meet Project construction schedules, Engineer's opinion of probable construction costs and of construction schedules shall be made on the basis of experience and qualifications as a professional engineer. Engineer does not guarantee that proposals, bids, or actual Project construction costs will not vary from Engineer's cost estimates or that actual construction schedules will not vary from Engineer's projected schedules.

ARTICLE 12 - REUSE OF DOCUMENTS

All documents, including, but not limited to, drawings, specifications, and computer software prepared by Engineer pursuant to the Agreement are instruments of service in respect to the Project. They are not intended or represented to be suitable for reuse by Owner or others on extensions of the Project or on any other project. Any reuse without prior written verification or adaptation by Engineer for the specific purpose intended will be at Owner's sole risk and without liability or legal exposure to Engineer. Any verification or adaptation requested by Owner shall entitle Engineer to compensation at rates to be agreed upon by Owner and Engineer.

ARTICLE 13 - OWNERSHIP OF DOCUMENTS AND INTELLECTUAL PROPERTY

Except as otherwise provided herein, engineering documents, drawings, and specifications prepared by Engineer as part of the Services shall become the sole property of Owner upon receipt of payment by Engineer of amounts due and owing under this Agreement, however, that both Owner and Engineer shall have the unrestricted right to their use. Engineer shall retain its rights in its standard drawing details, specifications, data bases, computer software, and other proprietary property protected under the copyright laws of the United States. Rights to intellectual property developed, utilized, or modified in the performance of services shall remain the property of Engineer. Owner shall have the unlimited right to the use of intellectual property developed, utilized, or modified in the performance of the Services at no additional cost to the Owner.

ARTICLE 14 - TERMINATION

This Agreement may be terminated by either party upon written notice in the event of substantial failure by the other party to perform in accordance with the terms of this Agreement. The nonperforming party shall have fifteen calendar days from the date of the termination notice to cure or to submit a plan for cure reasonably acceptable to the other party. Owner may terminate or suspend performance of this Agreement for Owner's convenience upon written notice to Engineer. Engineer shall terminate or suspend performance of the Services on a schedule acceptable to Owner. If termination or suspension is for Owner's convenience, Owner shall pay Engineer for all Services performed prior to the date of the termination notice. Upon restart, an adjustment acceptable to Owner and Engineer shall be made to Engineer's compensation. Neither Engineer, nor its subconsultants shall be responsible for errors or omissions in documents which are incomplete as a result of an early termination under this Agreement.

ARTICLE 15 - DELAY IN PERFORMANCE

Neither Owner nor Engineer shall be considered in default of the Agreement for delays in performance caused by circumstances beyond the reasonable control of the nonconforming party. For purposes of this Agreement, such circumstances include abnormal weather conditions; floods; earthquakes; fire; epidemics; war, riots, or other civil disturbances; sabotage, judicial restraint, and inability to procure permits, licenses, or authorizations from any local, state, or federal agency for any of the supplies, materials, accesses, or services required to be provided by either Owner or Engineer under this Agreement.

Should such circumstances occur, the nonconforming party shall, within a reasonable time of being prevented from performing, give written notice to the other party describing the circumstances preventing continued performance and the efforts being made to resume performance of the Agreement.

For delays in performance by Engineer, as set forth in Attachment E, Project Schedule, which are caused by circumstances which are within its control, such delays shall be documented on the Engineer's Project Performance Evaluation form. Said form shall be completed at the conclusion of Project and acknowledged by both Owner and Engineer. Completed form shall be retained by Owner for a period of five years and reviewed prior to consultant selection for City projects.

In the event Engineer is delayed in the performance of Services because of delays caused by Owner, Engineer shall have no claim against Owner for damages or contract adjustment other than an extension of time.

ARTICLE 17 - WAIVER

A waiver by either Owner or Engineer of any breach of this Agreement shall be in writing. Such a waiver shall not affect the waiving party's rights with respect to any other or further breach.

ARTICLE 18 - SEVERABILITY

The invalidity, illegality, or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of this Agreement shall be construed and enforced as if this Agreement did not contain the particular portion or provision held to be void. SCOPE OF SERVICES

BASIC SERVICES

The Project is specifically defined below:

Assist the City of Leavenworth with development of 2025 bid packages for pavement maintenance projects to be constructed in the Spring/Summer of 2025. The bid packages planned for the 2025 pavement maintenance projects are anticipated to include up to two (2) bid packages with an approximate budget of \$2M inclusive of design fees. These packages include Granite Seal and/or Ultrathin Bonded Asphalt Surfacing (UBAS), mill and overlay and a parking lot package. For each of the two (2) bid packages, two review submittals will be made which includes Field Check (50%) and Final Plans (100%). Bid Documents will be submitted to the City of Leavenworth for Advertisement. Fee buildup assumes that two (2) bid packages are completed and submitted for advertisement by the end of calendar year 2024.

- Task 1. Project Management task will include the following:
 - Project Administration and Management This includes client management, project management, and invoicing.
 - 2. Project Meetings and Site Visits include the following:

 - c. Street segment list development and modification for granite seal package and mill and overlay package. Street segment list selection tool will be used for initial project lists. utility coordination, SWPPP, NOI or other permits are included. Pavement marking plans will be included only for those streets that currently have pavement marking and will be limited to replacement of existing pavement marking. No new pavement marking plans are included in this scope. Only one (1) street specific traffic control plan is included in Task 2 (likely a UBAS project if selected). Plan sheets will not be a standalone plan set but rather will be added into the Project Manual for bidding. Bid Package will include up to seven (7) street segment bid alternates.

3. Prepare Quantities and Engineers Estimate for each submittal.

Task 3. The Mill and Overlay package will include the following:

- Acquire plans and project manual (bid package(s)) from the City of Leavenworth for the 2024 projects for Mill and Overlay. Incorporate any updated details/specifications from the plans/project manual received from the City of Leavenworth.
- Project Manual will be prepared and shall include a summary of quantities table (per street segment) for both base bid segments and alternate bid segments.
- 3. Prepare design plans to include Title Sheet with location map, typical section and patching details, standard details, plan layout sheets and pavement marking using public domain aerial background. Full depth pavement patch locations will not be included but quantities will be estimated from a site visit. Inspector will decide actual limits of pavement patch in the field. Pavement marking plans will be included only for those streets that currently have pavement marking and will be limited to replacement of existing pavement marking. Plan sheets shall show limits of mill/overlay, approximate location of sanitary and storm sewer manhole locations, and approximate locations of water valves. Utility infrastructure will be identified using City's GIS and verified with google street view and/or captured during project site visit. Projects could include curb and gutter replacement, sidewalk and sidewalk ramps, and driveways. Generally, detailed design elevations will not be provided on the plans, but rather reference will be made to the standard details and requirements except in those areas that elevation information is critical/sensitive. Critical/sensitive areas with elevation information will be limited to two ramp quadrants or locations of similar size/extents. The survey for these areas is included/limited per subtask 4 below. No SWPPP, NOI or other permits are included in the scope for Task 3. Only three (3) street specific traffic control plans are included in Task 3. Bid Package will include up to three (3) street segment bid alternates.

Project will also include a parking lot as well that will be limited to a mill and overlay with full depth patching and pavement marking plan. Areas of full depth patching will be identified on a single plan sheet. Field work will not be completed by Benesch. Markups for placement on plan sheet will be provided to Benesch. No survey is included for the parking lot, but item 4 below can be included in a site visit to address a specific need on the proposed parking lot rehab.

- 4. Up to one (1) days of survey is estimated for this Task to confirm elevation sensitive items.
- 5. Prepare Quantities and Engineers Estimate for each submittal.

Task 4. Pavement Tool Instructions will include the following:

- As a followup to the Pavement Management Financial and Project Selection Tool, the City has requested the
 development of an instruction manual that outlines the process for using the tool. The process will be
 highlighted with step by step instructions for how to use the tool and will be limited specifically to adjustment
 of funding, weighting of various factors, treatment costs and pci criteria. This effort is budgeted at 24 hours
 of time.
- 2. Benesch staff will make one (1) presentation to the City Commission and this will include time for development of a powerpoint presentation as well. This will be limited to up to two (2) staff members attending a meeting for up to two (2) hours exclusive of travel time. Travel time and mileage for this trip is included in the fee buildup.

- Field Inspections are limited in number and hours per the scope. Additional or extended visits not anticipated can be provided but may be subject to additional scope/fee.
- No Public Meetings or Public Meeting preparations are included in this scope of services.
- One City Commission meeting preparation or presentations is included in this scope of services.
- Direct Costs (mileage) are limited to those number of trips specifically referenced in the scope of services. Additional visits/trips not anticipated can be provided but may be subject to additional scope/fee.

- Surveying is likely required in some locations and is limited to one field day (see Tasks). No legal descriptions or property boundary/title research is included.

- No DBE Goals are Established for this Scope and Agreement.
- Benesch will be re-engaged annually as part of this agreement for a maximum of Five (5) Years. New annual agreements will be negotiated each year service is requested.

The contractor shall not participate either directly or indirectly in the discrimination prohibited by Section 21.5 of the Regulations, including employment practices when the contract covers a program set forth in Appendix B of the Regulations.
- (3) Solicitations for Subcontracts, Including Procurement of Materials and Equipment In all solicitations either by competitive bidding or negotiations made by the contractor for work to be performed under a sub-contract, including procurement of materials or leases of equipment, each potential sub-contractor or supplier shall be notified by the contractor of the contractor's obligations under this contract and the Regulations relative to nondiscrimination on the grounds of race, color, sex, or national origin.
- (4) Information and Reports The contractor shall provide all information and reports required by the Regulations or directives issued pursuant thereto, and shall permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the contracting agency or the appropriate federal agency to be pertinent to ascertain compliance with such Regulations, orders and instructions. Where any information required of the contractor is in the exclusive possession of another who fails or refuses to furnish this information, the contractor shall so certify to KDOT or the USDOT as appropriate, and shall set forth what efforts it has made to obtain the information.
- (5) Sanctions for Noncompliance In the event of the contractor's noncompliance with the nondiscrimination provisions of this contract, the contracting agency shall impose such contract sanctions as it or the USDOT may determine to be appropriate, including, but not limited to:
 - (a) Withholding of payments to the contractor under the contract until the contractor complies, and/or;
 - (b) Cancellation, termination, or suspension of the contract, in whole or in part.




