Survey results

The city of Leavenworth issued a Survey Monkey online for the purposes of obtaining feedback about the 2025 budget proposal.

The survey was active July 15, 2024 – July 21, 2024.

Results of the survey are as follows.

City of Leavenworth 2025 Budget Survey:

The City of Leavenworth is currently considering the proposed 2025 Budget with a flat mill levy. A flat mill levy would result in the city collecting \$318,000 more in property tax than it did in 2024, due to an increase in citywide property valuations. A revenue neutral mill levy would result in the city collecting the same amount of property tax that was collected in 2024. To accomplish a revenue neutral mill levy the budget team would need to cut \$318,000 from the proposed budget.

How about cutting all of the unnecessary expenses. Start running the city like a business would. As a business owner, I take care of my equipment and run it as long as it makes financial sense. There is no way we need a new swat truck or dump truck or roller truck All of this unnecessary spending is absurd. Stop wasting our money.

The indoor community pool at the Riverfront Community Center is a valuable city service. It provides excercise for pool patrons year round. No matter the weather the pool is available for folks working on their health. My mother suffered from several Strokes and has greatly improved due to the excercises she performs in the pool. Another benefit of the pool is the friendships and support each of us have formed. Members of the Water Walking class have become emotional support for folks preparing for surgery or recovering from medical situations. Milestones are celebrated and cheered. We have formed friendships that carry on outside of pool time. This is the only indoor pool of its size available to the public. The pools on Post at Ft Leavenworth are not available to the general public. The pool is also the venue for the Leavenworth High School Swim team. Practices and Meets are held in the RFCC. Several patrons come to the indoor pool for Physical Therapy. They, with their PT, increase range of motion and strength in the water that cannot be gained on land. As to the Community theater, all the elements needed for community plays and musicals can be supported by the LHS Performing Arts Center. The LHS PAC was renovated several years ago. It is substantially larger than the downtown venue and is already taxpayer subsidized by property taxes and school taxes.

This city has precious little activities for kids as it is. Closing the Theater and the pool would dramatically lessen the opportunities for future generations. I have been involved with the Community Theater for almost 25 years, my kids have been involved their whole lives. We have made friendships that will last a lifetime. If the city were to close that building, you would be robbing that opportunity from so many people. I think you could find easier places to reduce funding, such as salaries of the city/county politicians, reducing the resurfacing of roads that honestly don't need it while ignoring those that do (18th street between Thornton and Lecompton), and other wasteful projects that are in place only to pad someone's pocketbook.

The Performing Arts Center and the RFCC pool are two of the main places here in Leavenworth that I attend regularly. Getting rid of these things would remove several of my primary hobbies, and result in trying to find things to do OUTSIDE of Leavenworth.

Lower raises for staff. No one else gets more than the 3-4% COL increase, why should you?

Our property taxes increased by almost 40% since we bought our home in 2021. Plus, our water, sewage, and trash bill has increased. Yet, the trash service has declined. No more taxes.

in light of decreasing populations, aging citizenry, price inflation, income stagnation, etc, all levels of governmental functions need to focus on core services & projects & eliminate subsidies on less essential activities. there IS such a thing as living within a budget that doesn't continually expand- (at least some) taxpayers are constantly FORCED to do so. it's time that government started scaling back, so we can all share in responsible fiscal policy that preserves citizen's opportunity to live without stress of trying to pay for cost increases in EVERYTHING

The indoor pool is very important for nonimpact exercise for all ages. Raise the price, slightly not significantly, to help costs. Even an increase from \$35.00 per swim ticket to \$40.00 would help elderly and people of all ages get a good non-impact workout. Please don't close the indoor pool1

"No one wants to pay more taxes! There has to be some redundant positions at the city hall. I know this because I am a former employee.

What is the Rental Coordinator? How was this handled before there was this position?"

All levels of government, including City government, should stop using public resources to enact programs that pick winners and losers in the private sector. City government should focus on quality of life issues for residents and impact the business community only to establish an environment that promotes economic prosperity and encourages entrepreneurship.

3. If possible the city could reduce the amount for the business grant program until finances can be restored. I don't think we should eliminate the Rental Coordinator Position. As we all know Leavenworth has an abundance of rental properties.

As a taxpayer I do not like the idea of cutting programs or opportunities for the citizens of this community. I also don't mind paying a few extra dollars in taxes when the money is being used wisely."

"I haven't seen that the city has. done anything (or shared info if they have) to find ways to make the theatre or pool profitable. I'm assuming the \$75k (+/-) saved by not supplying trash bags this year reduced the budget.

Do not raise our taxes more.

Do not take away our pool, library, theatre, or historic buildings. Start working to keep our legacy and quit trying to make us just another KC suburb.

This survey seems to have only been shared via Facebook. Did you not learn this was not effective when you did the trash surveys? You are not getting a true pic of what this town thinks. You eliminate too much of the population. Print it in the paper, send it in the mail, include it on the back of the water bill, give it to church groups, council on aging, organizations, something. It seems you are just checking a box to say you seeked input."

I would much rather pay more taxes than cut things that make Leavenworth a great place to live. How do we attract new businesses when we don't have nice things to offer?

Cut school administration costs and positions

I do not want my tax dollars supporting programs that are operating at a loss, such as the theater or the pool. I was surprised to learn this information from the recent article in the LV

Times. If these programs had additional outside funding sources that would not place the financial burden on the tax payers, I would support retaining them.

I have been using the Riverfront indoor pool for exercise three days a week since 2019 when I retired as an educator. I have had bilateral knee and hip replacements so water exercise is highly therapeutic. You could direct me to the outdoor pool, but I am also a skin and breast cancer survivor. I cannot be exposed to the sun. This morning, I saw another woman enter the pool by use of the ADA chair lift for the 10:00 water walking program. If you close the pool, how would she be able to exercise? Please reconsider your decision with regard to closing the Riverfront indoor pool. Thankyou.

Cutting city programs is not going to have any effect on property taxes. Property taxes usually increase every year anyway because they are based on the assessed value. Keeping the mill levy flat means that the city won't be increasing our property taxes. Cuts to the budget will not reduce property taxes. They will only reduce the quality of life in our city. I don't see the need for cuts at this time.

Revenue neutral budgets are not practical.

"Riverfront Community Pool benefits the health of many residents, especially seniors with joint problems. More and more doctors recommend that patients with joint issues exercise in the water.

The pool also provides the location for the Leavenworth High swim team to practice and compete.

If the indoor pool closed, the lifeguards would likely find jobs elsewhere; and then it would most likely make it difficult to find enough lifeguards to staff the outdoor pool for the summer.

Children need the opportunity to learn to swim in order to prevent an increase in the number of drownings that occur each year."

I was born in Leavenworth and have been attending the community theatre there my entire life. I have even returned more recently to be a performer. This theater is a Leavenworth tradition and should not be closed or torn down. It's an important part of not just the Leavenworth community but also the Kansas City metro.

If Riverfront has a gym & walking track why close the pool? Surely people who go there & have PAID for memberships would want a pool. Closing the theater means more blighted spaces. People need assistance with rental issues. New military families move into this community all the time. They often return here to retire. What will they think as all these services are dropped? Why come to Leavenworth if good things are dropped? Non military People we see these cuts and move somewhere else and take their tax dollars with them. Revenue neutral budgets are not the way to go!

Last year the library was targeted. Revenue neutral budgets are not always practical. Closing the theater would mean another empty building and downtown has enough of those. "

Hold city salaries at current rate. Reduce number of city owned (COA and LV) transportation vehicles. Charge higher fees for recreational venues (aquatics, exercise, etc).

Close any pool in Leavenworth and I will make it my life's mission to make sure every politician who votes yes or is apart of said removal is removed from office.

I appreciate the opportunity to look at the proposed budget and I went through the entire document. My father-in-law was a successful small-business owner who said, "Watch the pennies and the dollars will take care of themselves." Tax payers would appreciate a hard attempt at removing line items like \$2K for coffee supply for City Hall (and more money for other departments). \$7500 for the City Christmas party? \$6500 for Spring Clean-up T-Shirts? \$3K for Planters II Tennant events? My children have taken swimming lessons during the winter months at Riverfront Community Center. This is an important and lifesaving skill and having it close by makes it easier for me to fit this essential class into our busy schedule. They've also gone swimming there in the winter months and it is much appreciated as it's also the closest and most affordable indoor pool for miles. We have also attended a few shows at the community theater. It is a gem of a local program and to be housed in such a beautiful building is the cherry on top. It gives such a professional feel to the productions. Also, the productions themselves lend a synergy to the downtown area. How many people come from around the region to see a production there and also happen to dine at a restaurant either before or afterwards? Browse through one of the downtown shops in the vicinity (particularly for a Saturday evening show, people can make a whole day of being downtown and taking advantage of all it has to offer!)? If the theater were to close, and the community theater putting on the productions couldn't find a new home, it would be a major loss to the arts community, the residents who miss out on enriching arts and humanities/cultural events that make life more special, and the local neighboring businesses that are the recipients of the foot traffic these events attract. Finally, the business grant program is another important factor for entrepreneurs to consider opening a business in downtown Leavenworth. A thriving business district helps everyone. It brings a wider variety of potential visitors to possibly spend their money in one or more businesses. In fact, I daresay that all three of these possible cuts are truly connected to each other and really enhance the

quality of life overall for not just residents of Leavenworth, but residents of Leavenworth County and even neighboring communities in our region such as Atchison, KS; Weston, MO; and Platte City, MO. So while I am not a resident who would feel a direct impact from the rise in my property taxes, I do spend money in downtown Leavenworth frequently (at least 1-2 times a week) and can attest to the high quality of life these places offer all of us. I would truly miss these things if they were to be cut and permanently done away with. It would be a grave mistake.

I have lived in Leavenworth all my life. It should be a thriving city with its history similar to that of Weston. Instead, we constantly cut down opportunities & close those things that mean something to its citizens. Find some other way to balance your budget.

"I will be honest I am not fully in tune with the Leavenworth budget. However. On point #2 adopting a flat Mil Levy, what would that be? I mean to really be able to respond to this question the city needs to say what that flat rate would be. On points #3 and #4. These seem more like a scare tactic. I know that hard decisions need to be made in developing budgets, but I would imagine the two proposals are near and dear to a lot of people in Leavenworth. Not to mention these appear to me to be single year fixes not a long-term solution to adjusting the budget to the realities of falling tax revenues. (Loss of the prison tax revenue) On Point #6. I think eliminating the rental coordinator position, to me, sound like a good starting point. I would also say a full top to bottom review of the city of Leavenworth manning structure may in fact find more savings cuts. Ending the business grant, seems to me, that Leavenworth might be shooting themselves in the foot. I think attracting and developing new business to Leavenworth

is the key to gaining more tax revenue, not raising property taxes on the existing homeowners, i.e. expand the tax base. For example, I recently attended and spoke at the planning and zoning board meeting where the proposal to grant the use of Ables Field as a trash transfer point was the agenda. While the current proposed location is in the wrong spot and I don't agree with that location, there is a perfectly usable location right behind Ables Field east of 2nd street with what appears to be a skeletal structure of a large warehouse already there. My point is expanding city revenue but in the right place.

Disappointed that mainly one or two leaders of our community are visible in the community who voted for them. Where are the rest?

Revenue neutral does not work. It has become a trend that some think solves issues. A political fad diet!

The indoor swimming pool supports the improvement of residents health through activity and exercise.

Most of the money can be saved by reducing pay increases. %'s are way too high.

You need to do more cuts than a mere \$318000

While in this current economy, people are struggling. I am not a proponent of raising taxes, but these cuts would harm crucial programs that our city offers.

"Write the options more clearly--""revenue neutral mill levy"" is not what is being considered.

Three points: 1 - you are misleading residents and constraining the solution sets by looking only at what you label as budget cuts. You should be looking at broader proposals to reduce or eliminate the need for increases. 2 - It is sad that our talented city staff with high expertise in all aspects of city operations could only come up with a very limited set of proposals for budget cuts that, frankly, appear as if staff designed them to create controversy and limit city council discussions of the budget. 3 - By limiting this survey to residents only you have done a great disservice to a large group of significant property tax payers. Those three vested interests are their business health, their employees, and their customers many of them are also residents.
